## **Matters Arising**

1. Mt. District's Notice of Motion to alter the Rules to include the West Track.

Prior to this matter being put to the vote, a letter from Mt. District was read to the Meeting. This letter expressed the Club's dis-satisfaction that the March Delegates Meeting Minutes had only been forwarded one week before the April Meeting not giving Clubs sufficient time to have meetings and discuss the issue. They requested the vote be held over to the May Delegates Meeting. The President stated that it was up to the Delegates to take matters to Club Meetings and not rely on the distribution of the Minutes. However he sought the view of the Meeting and the consensus was that holding the matter over to the May Delegates Meeting would not alter the vote. As a result, The President decide to put the Notice of Motion to incorporate the West Track in our lines of flight to this Meeting.

The Motion was **defeated**

2. Letter from Les Caracella requesting the VHA to reconsider his payment of his 2013 Up-front Fee Payment

This matter was referred to the Race and Finance Committee and their recommendation was put to the Meeting. The Race and Finance Committee Recommendation was that the outstanding \$960.00 be paid in full.

After some discussion it was Moved N.Fleming Seconded K. Crawford. that Les Caracella pay \$55.00 per week commencing no later than the 1<sup>st</sup> Club race. This payment is to be maintained until his Up-front Fee Payment from 2013 is paid in full. If this payment is not made each week, he would become an un-financial Member and would not be able to race.

This payment has no effect on his 2014 Up-front Fee Payment which must be paid in the normal manner.
