Report as per the Annual Meeting Report. Also dealing with miscellaneous regulatory matters.

General Business

1. Rota Virus Update: Dr. Colin Walker attended the meeting and gave the Delegates an update on the trial testing and how the process was going. He was hopeful of a vaccine by perhaps August and then a truncated racing season but this is a 'best case scenario' so we remain hopeful.

2. RSPCA New South Wales: The Secretary referred to a press release from the RSPCA NSW. The release commences with, "RSPCA NSW is issuing a stern warning that those pigeon federations who are considering racing in the 2017 season would be acting irresponsibly."

It goes on to say, inter alia, "The RSPCA implores those federations who have not yet cancelled pigeon racing for the 2017 season to act responsible in the interest of pigeon welfare and postpone racing pending the development of a vaccine."

It also points out that the activities of spreading the disease may constitute animal cruelty offences.

As a pigeon fraternity, we have gone to great pains over the last few years to try and ensure we do not incur the wrath of bodies like the RSPCA and animal activist. We have paid much greater attention to transport, weather, liberation conditions including wind and heat. We have developed a Code of Conduct to illustrate that pigeon welfare is our priority. Yet after the RSPCA NSW has made its position clear, certain bodies are still planning to conduct racing and most of those races will be from NSW. To sub our noses at the NSW RSPCA by conducting racing this year without a

vaccine is sheer madness and may well haunt us in the years to come and may place pigeon racing under a more severe spotlight given what RSPCA NSW would see as a demonstrated flagrant disregard for pigeon welfare. We are Victorians but over 90% of races on the north and north-east track are conducted from New South Wales. To ignore the RSPCA NSW is to say the least, not smart.

I encourage all members of the fraternity who have decided to race this year to re-consider your position in the interest of pigeon welfare and the sport as a whole now and in the future.
