Pigeon Health – Dr Colin Walker addressed the meeting regarding Rota Virus (Hepatitis) and the losses of pigeons in the early races. It was his opinion that more 50% of the pigeon fraternity do not vaccinate for Rota Virus. A summary of Colin's recommendations for various vaccinations will be circulated to members in due course.

General Business

- Carrieton 2 John Van Beers addressed the delegates regarding South East club request for the Carrieton 2 race to be reinstated on the same day as the 600 from Blinman. He was critical of the Executive Officers decision not to reinstate the race. John conceded that there was little that could be done to hold the race on the scheduled date due to inclement weather but believed that the race could have been held on the same day as Blinman. Steve Brown stated that although the idea had some merit, it is the Executive Officers who make important decisions in between delegates meetings and the majority of the committee were reluctant to change the race status from "cancelled" to "active."
